## Legal expenses coverage

Provides coverage for complaints including professional misconduct, sexual abuse or sexual harassment filed with the provincial regulatory boards. The insurer will provide coverage for legal expenses applicable to any disciplinary/investigation proceedings with a regulator/provincial college.

## Criminal defense costs reimbursement coverage

May cover you for charges filed under the criminal code. Since criminal acts are excluded, the insurer does not have the duty to defend. The insurer will pay on behalf of the insured party, provided a) the criminal charge arises from the individual's practice in Canada, and b) the insured individual is found not guilty of the criminal charge.

*Please note: Includes the sexual abuse therapy and counseling fund coverage for insured persons in Canada. This endorsement provides a maximum funding of \$20,000 for the rehabilitation of a person who, while a patient, suffered abuse in the course of an insured person's professional practice.*

## Extensions of coverage

Out-of-country coverage is automatically included for 120 consecutive days at no extra cost for individuals who travel outside Canada while:

- Accompanying Canadian patients
- Attending academic courses
- Participating in professional exchange programs with other countries

## Clinic professional liability insurance coverage

Clinic coverage extends limits of liability to protect the clinic in the event the clinic is named in a claim involving an employee or owner of the clinic. This coverage provides protection for billed professionals. The cost for this coverage is based on the number of **professionals**.

If additional health services are provided in a clinic, coverage for multiple disciplines should be purchased. If you require multidisciplinary clinic insurance, please complete an Aon Healthcare Advantage application for coverage and rates.

## Extended reporting period

Extended reporting period coverage can be provided to those individuals who are suspending or discontinuing their practice:

- 12 months for \$50 additional cost
- 24 months for \$100 additional cost
- 36 months for \$150 additional cost
- 60 months for \$200 additional cost
- Unlimited time for \$250 additional cost

## Claims reporting procedures

Claims, actual or potential, must be reported to Aon within 30 days of you being made aware of a possible claim. No written or oral statement should ever be made, except upon the advice of the insurer. A member should never offer compensation to a patient, nor admit liability, as this could interfere legally with the insurer's handling of the claim.
